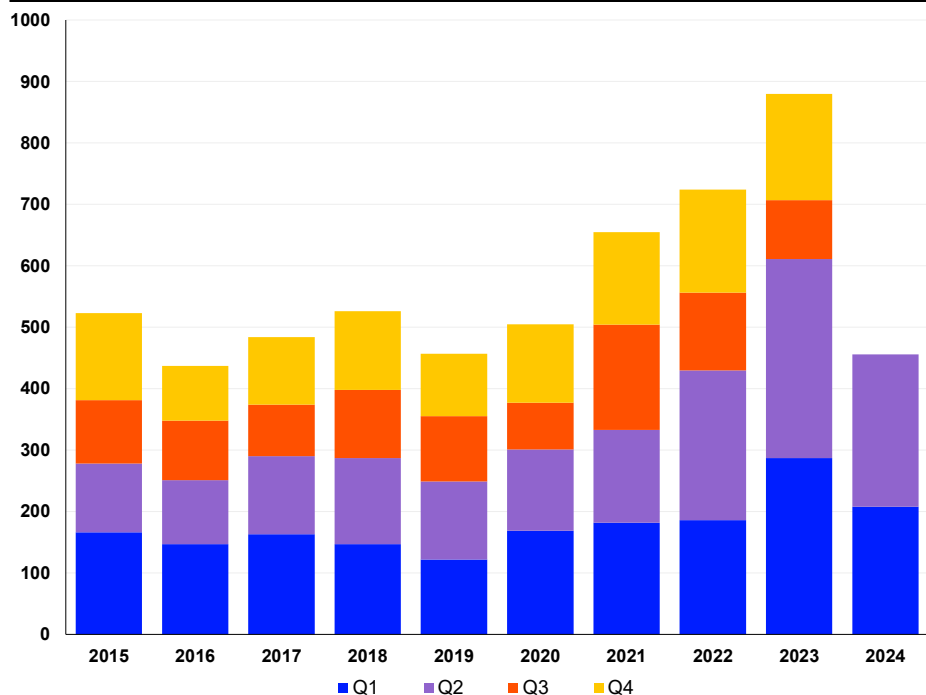


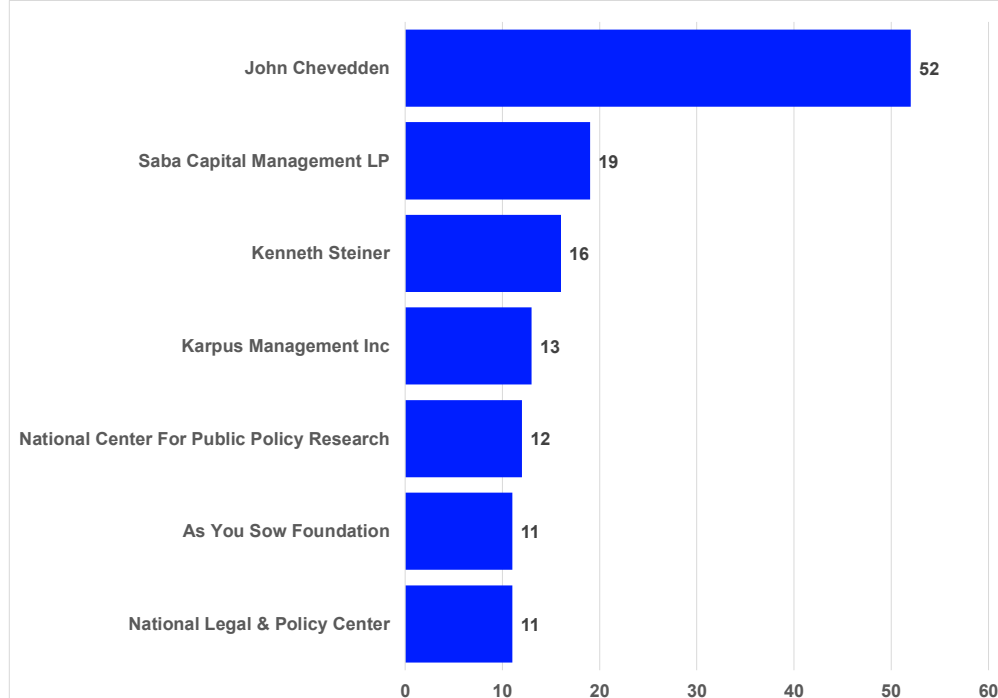

Fast Facts

Activists launched nearly 456 campaigns during first half 2024, down 25% compared to the first half of 2023

Meta Platforms Inc is the largest target by market cap during the first six months of 2024

John Chevedden launched 52 campaigns, leading all activist investors during the first half of 2024

Financial, Consumer Cyclical and Industrial firms were the most targeted sector during the first half of 2024

Demands for Shareholder Rights and Board Representation account for 84% of activist demands

Goldman Sachs led all financial advisors by number of deals, advising on 37 campaigns

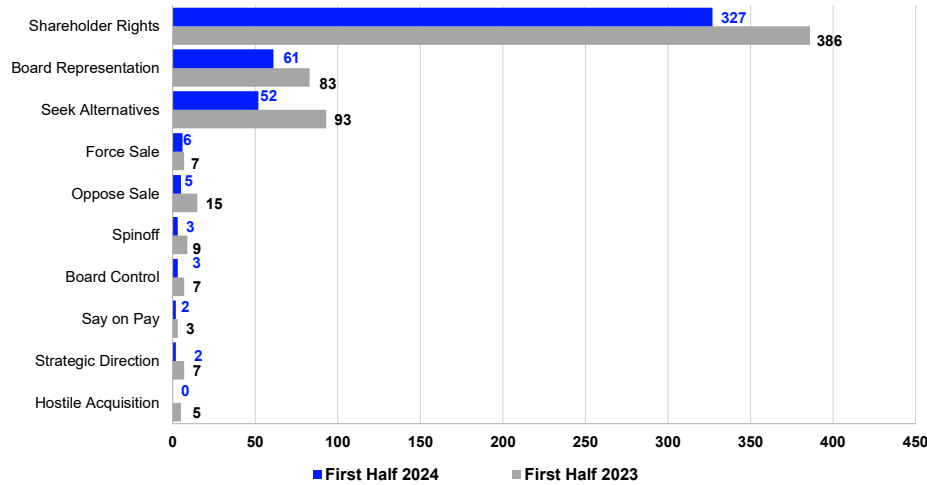

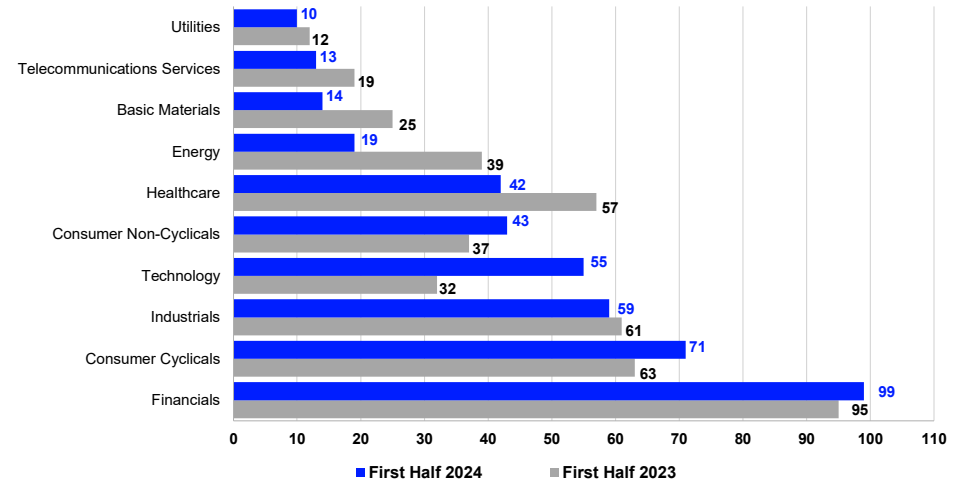

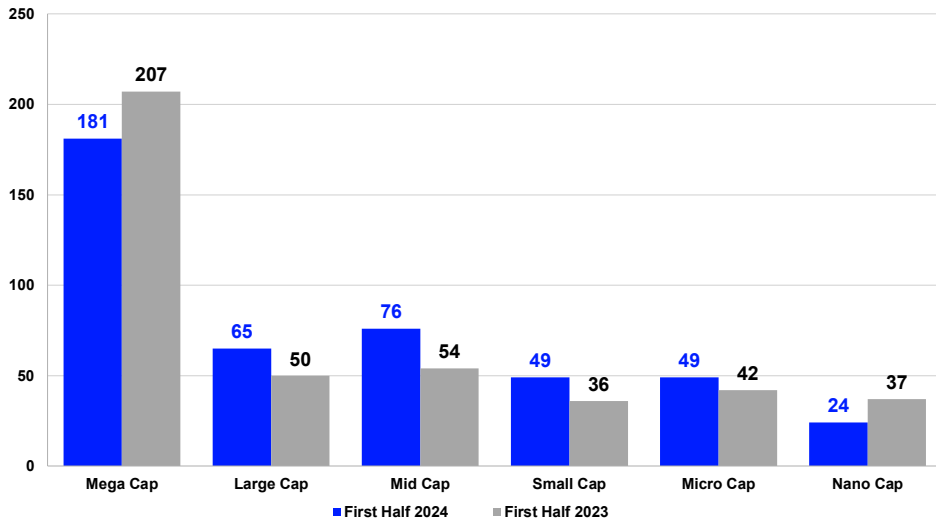
Announced Campaigns by Demands



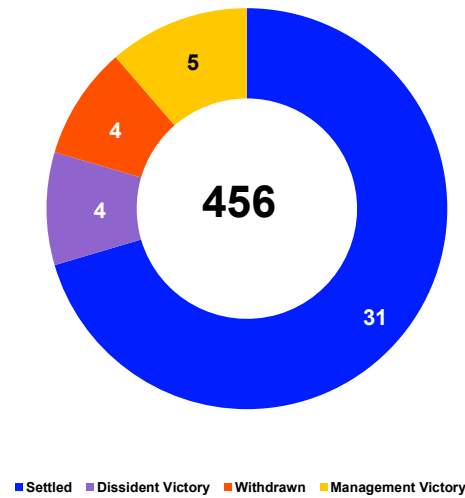
Announced Campaigns by Sector

• Shareholder Activism campaigns are tracked by "Intent" mainly from Item 4 clauses in Schedule 13D US Public Filings, other SEC Filings (DEF 14A), Media Sources, Press Releases, Public Shareholder Proposals, Public Letters to Management and Regional Governance Reports. Activist Investors must display a clear confirmation of actions or the potential to take defined actions against a target company to be included in the database.

• Scope of coverage includes value creation, changes to the Board of Directors and intent to persuade M&A activity.

• Advisor rankings are compiled via public sourcing and quarterly survey disclosures.

• Campaign count is based on the announcement date.

• All data is as of October 1st, 2024 and sourced from Workspace by LSEG.
